

# TRANSFER OF CREDITS (ARTICULATION) AGREEMENT Between

<b>Cankdeska Cikana Community College</b>	<b>University of Mary</b>
---	---------------------------

This Agreement is entered into between **Cankdeska Cikana Community College** (hereinafter CCCC), and **University of Mary** (hereinafter UMary). This Agreement and any amendments and supplements, shall be interpreted pursuant to the laws of the state of North Dakota.

**Whereas:**

- CCCC has established undergraduate programs in which students earn an AA, AS, AAS, diploma, or certificate (hereafter sending programs) and
- UMary has established undergraduate programs in which students earn a BA, BAN, BS, BAS, BMus, BSN, BSRT, or BUS, (hereafter receiving programs),

The receiving institution will facilitate credit transfer between sending and receiving programs and provide a smooth transition from one related program to another.

**It is mutually agreed:**

**1. Admission Requirements**

The receiving institution's admission and program admission requirements apply to both direct entry students and to students who transfer under this agreement.

**2. Transfer of Credits**

The receiving institution will accept transfer credits from the sending institution in accordance with its Transfer of Credit policy<sup>1</sup> and as described in the Program Articulation Tables (hereafter Tables). Tables shall be developed program-by-program upon request by either institution, and will be reviewed annually by the receiving institution's Office of the Registrar to ensure consistency with each institution's Catalog. The Tables shall be approved by the sending institution before implementation. The sending and receiving institutions shall cooperatively work with students to resolve the transfer of courses should changes to either sending or receiving programs occur that are not reflected in the Tables. When a student notifies the receiving institution of their intent to follow this agreement, the receiving institution will encode course waivers and substitutions.

**Implementation and Review**

The Chief Academic Officers or designees of the parties to this agreement will implement the Terms of this agreement, including identifying and incorporating any changes into subsequent agreements, assuring compliance with system policy, procedure and guidelines, and conducting a periodic review of this agreement.

**Effective Date and Duration**

This Articulation Agreement is effective on 02 / 12 / 2026 (insert date) and shall remain in effect until terminated or amended by either party with 30 days prior written notice.
